THIRD PARTY DATA PROVIDER TERMS AND CONDITIONS

Tradeweb Direct's fixed income electronic trading system and associated services (the "Tradeweb Direct System") make use of certain data products provided by third-party data providers. In addition to the rights and restrictions set forth in the agreement(s) that you have entered into with member(s) of the Tradeweb group ("Tradeweb"), your and your authorized users' use of the Tradeweb Direct System are subject to the following terms and conditions relating to such third-party provider data available on the Tradeweb Direct System:

Interactive Data Pricing and Reference Data

1. No Warranties

INTERACTIVE DATA PRICING AND REFERENCE DATA LLC ("IDC") AND ITS SUPPLIERS MAKE NO WARRANTIES, EXPRESS OR IMPLIED, AS TO MERCHANTABILITY, FITNESS OR ANY OTHER MATTER.

2. Limitation on Liability

(a) IDC and its suppliers shall have no liability to you, or any third party, for errors, omissions, or malfunctions in any information, data, technology, or other products or services provided by IDC (collectively, the "IDC Services"), other than the obligations of IDC to endeavor, upon receipt of notice from you, to correct a malfunction, error, or omission in any IDC Services.

(b) You acknowledge that the IDC Services are intended for use as an aid to institutional investors, registered brokers or professions of similar sophistication in making informed judgments concerning securities. You accept responsibility for, and acknowledge that you are exercising your own independent judgment in, the selection of any of the IDC Services, the selection of the use or intended use of such, and any results obtained. Nothing contained herein shall be deemed to be a waiver of any rights existing under applicable law for the protection of investors.

(c) You shall indemnify IDC and its suppliers against and hold IDC harmless from any and all losses, damages, liability, costs, including attorney's fees, resulting directly or indirectly from any claim or demand against IDC or its suppliers by a third party arising out of or related to the accuracy or completeness of any data or other information received by them from IDC, or any data, information, service, report, analysis or publication derived therefrom. Neither IDC nor any of its suppliers shall be liable for any claim or demand against you by any third party.

(d) You acknowledge and agree that neither IDC nor any of its suppliers of data and information shall be liable for: (i) any special, indirect or consequential damages (even if advised of the possibility of such); (ii) any delay by reason of circumstances beyond its control, including acts of civil or military authority, national emergencies, labor difficulties, fire, mechanical breakdown, flood, or catastrophe, acts of God, insurrection, war, riots, or failure beyond its control of transportation or power supply; or (iii) any claim that arose more than one year prior to the institution of suit therefor.

3. Evaluations Terms and Conditions

In the event that you at any time receive data from IDC containing Evaluations (as hereinafter defined), rather than market quotations, for certain securities or certain other data related to such securities, the following additional provisions shall apply:

(a) Fixed income securities are typically complicated financial instruments. There are many methodologies (including computer-based analytical modeling and individual security evaluations*) available to generate approximations of their market value, and there is significant professional disagreement about which is best. No evaluation method, including those used by IDC, may consistently generate approximations that correspond to actual “traded” prices of the instruments.

(b) IDC’s methodologies used to provide the pricing portion of certain data may rely on evaluations; however, you acknowledge that there may be errors or defects in IDC’s software, databases, or methodologies that may cause resultant evaluations to be inappropriate for use in certain applications.

(c) You acknowledge and agree that you assume all responsibility for edit checking, external verification of evaluations, and ultimately the appropriateness of use of evaluations and other pricing data provided via the Service in your applications, regardless of any efforts made by IDC in this respect. You agree to indemnify and hold IDC completely harmless in the event that errors, defects, or inappropriate evaluations are made available to you, as the case may be, via the IDC Services.

The term “Evaluation” means: (i) mathematically derived approximations of estimated value, or (ii) individual security evaluations for miscellaneous issues, such as non-investment grade issues and issues with special terms and conditions which may not fit into any of IDC’s current evaluation models.
