## **Tradeweb Reports January 2019 Trade Volume**

NEW YORK – February 6, 2019 – Tradeweb Markets, a leading, global operator of electronic marketplaces for rates, credit, money markets and equities, today reported average daily volume of \$624.5 billion in aggregate for the month of January 2019, representing a new record.

Activity on Tradeweb trading platforms in January included:

- Average daily volume (ADV) of \$82.3 billion (bn) in U.S. government bonds and \$21.9 bn in European government bonds
- \$164.4 bn ADV in mortgages
- \$141.4 bn ADV in rates derivatives
- \$3.1 bn ADV in U.S. credit and \$1.3 bn in European credit
- \$885 mm in Chinese bonds
- \$7.2 bn ADV in credit derivatives
- \$171.4 bn ADV in repurchase agreements
- \$3.4 bn ADV in U.S. exchange-traded funds (ETFs) and \$1.5 bn in European ETFs
